MINUTES

Welcome and Opening Remarks

The meeting commenced with the IQAC Director, Prof. (Dr.) Ramesh Arora, welcoming all members and outlining the main objectives of the meeting. The focus of the session was on reviewing the progress in data collection and documentation for Criteria 1 and 7, with an additional review of other criteria.

Review of Progress on Criteria 1 (Curricular Aspects)

- The team responsible for Criterion 1 provided an update on data collection related to the curricular aspects, including course content, program outcomes, and feedback from stakeholders.

- Members discussed the challenges encountered, such as delays in gathering feedback and aligning program outcomes with updated curricular frameworks.

- Brief updates on other criteria (Criteria 2-6) were provided by respective teams, summarizing the current status of data collection and documentation.
- Criterion 3 (Research, Innovations, and Extension) was noted to have gathered much data, though additional work is needed on obtaining publications and faculty research data.
- Criterion 5 (Student Support and Progression) was discussed, highlighting improvements in data tracking for student placements and alumni engagement.
- The committee resolved to hold weekly review meetings to ensure timely updates on all criteria.

Action Items

- All teams were advised to complete their respective documentation by the specified deadlines and report any challenges to the IQAC Director promptly.
- A follow-up meeting was scheduled to assess the documentation quality and make final adjustments before submission.

Conclusion

The IQAC Director thanked all members for their contributions toward institutional quality enhancement. The meeting concluded with an emphasis on teamwork and dedication to completing the IQAC objectives within the stipulated timelines.
