MINUTES:

The IQAC Director welcomed the members and outlined the primary objective of the meeting, which was to conduct a detailed review and critical analysis of the data compiled under Criteria 4 and 6 for the Self-Study Report (SSR).

Review of Data under Criteria 4 (Infrastructure and Learning Resources):

- In charge of Criteria 4 presented the data concerning physical infrastructure, learning resources, library facilities, IT infrastructure, and maintenance of campus facilities.
- Key points like upgrades in infrastructure, library acquisitions, the effectiveness of ICT tools, and student feedback on facilities, were discussed.

Review of Data under Criteria 6 (Governance, Leadership, and Management):

- Incharge of Criteria 6 provided an overview of governance policies, administrative procedures, leadership practices, and the effectiveness of institutional management.
- The report covered data on strategic planning, faculty and staff development initiatives, decentralized governance, and participative management practices.
- Emphasis was placed on leadership involvement in institutional growth and the effectiveness of decision-making processes, along with documentation related to quality initiatives and staff development.

It was decided to include photographs of upgraded facilities, a summary of ICT-enabled classrooms, and data on student satisfaction with resources.

Incharge of Criteria 6 suggested highlighting best practices in governance, showcasing participatory management and leadership initiatives as part of the SSR.

A timeline was set for verifying and finalizing the data for Criteria 4 and 6, with a specific focus on cross-checking with relevant departments.

Suggestions were invited from the members on any additional points to enhance the presentation of data in the SSR.

Conclusion:

- The IQAC Director summarized the key points discussed and appreciated the efforts of the incharges in compiling and presenting the data.
- The next meeting to review the data of Criteria 1, 5 and 7 was scheduled for 20.02.2024.
