#### MINUTES

##### 1. Submission of the Final SSR

The Chair informed the members that the final Self-Study Report (SSR) has been successfully submitted to NAAC on 16 August 2024. Members congratulated the team for their dedicated efforts in ensuring a comprehensive and timely submission.

##### 2. Discussion on the Next Course of Action for the DVV Process

The Chair highlighted the importance of proactive preparation for the Data Validation and Verification (DVV) process. After a detailed discussion, the following action plan was outlined:

- A dedicated team comprising the IQAC Coordinator and Criteria In-charges will address any queries raised during the DVV process.
- Departments are instructed to ensure that all supporting documents for claims made in the SSR are readily available and accessible.
- A mock DVV review should be conducted internally by the IQAC to preempt potential queries and prepare appropriate responses.
- The team must adhere strictly to the NAAC's timeline for responding to DVV queries.

### 3. Review of Orientation Programs Conducted by Departments

The IQAC reviewed the orientation programs conducted in August for newly admitted students. It was observed that in some of the programmes having PG courses are yet to organise the orientation programme. Most departments have successfully covered the University's vision, mission, and other key policies.

It was recommended that the Departments should incorporate student feedback from orientation programs to improve future sessions.

### 4. Recommendation to Introduce New Value-Added Courses

The IQAC discussed the importance of offering value-added courses to enhance student skill sets and employability. The following recommendations were made:

- Departments are advised to design and propose value-added courses for approval.
- IQAC will provide a framework to standardize the structure and evaluation of these courses.
- Departments are encouraged to collaborate with industry experts and external organizations for course development and delivery.
